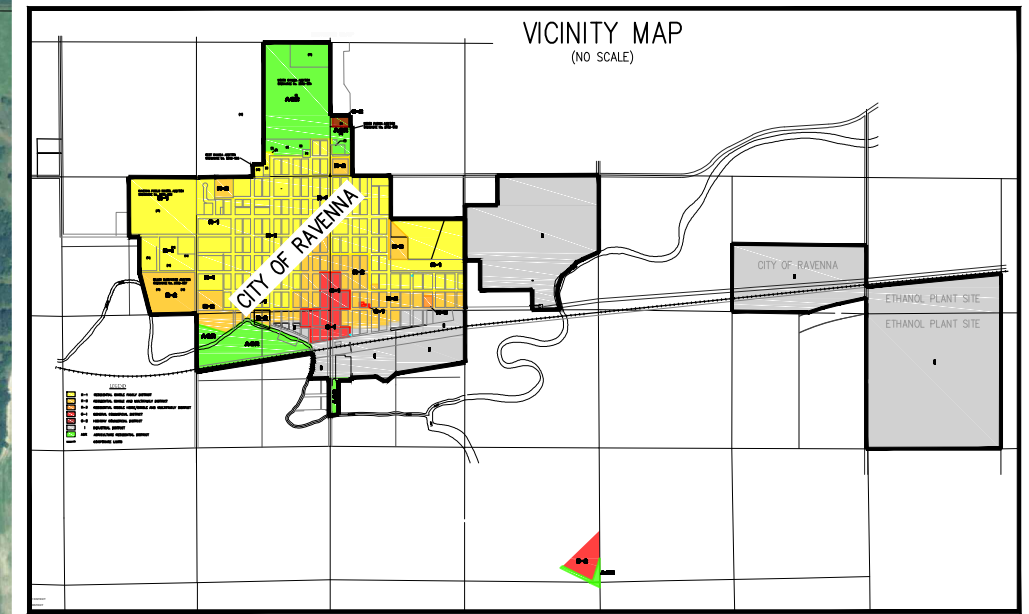


# OFFICIAL CORPORATE LIMIT CITY OF RAVENNA, BUFFALO COUNTY, NEBRASKA ZONING MAP
